Open Source Project Contributor License Agreement

Thank you for your interest in eXo Platform project. In order to clarify both the intellectual property license granted with Contributions from any person and the contributions' management guidelines outlined in order to achieve a Project's systematic growth, the eXo Platform Project must have a Contributor License Agreement (or Agreement) on files that has been signed by each Contributor, indicating agreement to the license terms below. This Agreement is for your protection as a Contributor as well as the protection of eXo Platform Project, its users and eXo Platform SAS which maintains the copyright of eXo Platform software and documentation. It does not change your rights to use your own Contributions for any other purpose. This Agreement:

- contains the programming, versioning and Contributions' management guidelines;
- clarifies that to your knowledge, the technology you've submitted was developed by you, and that you have authority to provide it;
- grants to eXo Platform SAS a perpetual, worldwide, no-charge, royalty-free, irrevocable, non-exclusive copyright license to use your Contribution and every derivative work according to eXo Platform licensing.

The Contributor accepts and agrees to the following terms and conditions for his/her present and future Contributions submitted to eXo Platform SAS. In return, eXo Platform SAS can use the Contribution only for inclusion in, or documentation of, eXo Platform software according to the eXo Platform licenses.

This Contributor License Agreement is filed by eXo Platform SAS. Please read this document carefully, complete it, sign it and send an original Agreement to eXo Platform SAS, 7 rue de la Paix, 75002 Paris - France. If necessary, you may send it by email (cla@exoplatform.com). Please keep a copy of the Agreement for your records.

Definitions:

“**Contributor**” is the copyright owner that is making this Agreement with eXo Platform SAS. “**eXo**” (eXo Platform SAS) is the entity owner of the copyright of eXo Platform software and documentation. “**eXo Platform Project**” or “**Project**” shall mean every organization, procedure, mean, practice, term, condition and license used by eXo Platform SAS for the aim of the free / open source eXo Platform products's development by means of all its software components and documentation pointed out on the project site:

<https://www.exoplatform.com>. “**Contribution**” shall mean any original work of authorship, including any modifications or additions to an existing work, that is intentionally submitted by the Contributor to eXo for inclusion in eXo Platform software or documentation. For the purpose of this definition, “**submitted**” means any form of electronic, verbal or written communication sent to eXo, including but not limited to communication on electronic mailing lists, source code control systems and issue tracking systems that are managed by eXo for the purpose of discussing and improving eXo Platform software and documentation, but excluding communication that is conspicuously marked or otherwise designated in writing by the Contributor as “Not a Contribution”.

Programming, versioning and contributions’ management guidelines:

The Contributor agrees and commit himself to respect both the Contributors’ coding, writing, versioning and management guidelines and the Contributor’s acceptance and termination procedure, as follows.

Software Contribution

The Contributor must release his / her Contribution in the eXo Platform Project’s SCM repository (Source Control Management). The eXo Platform Project uses the best practices available in the free software / open source community. Therefore, eXo Platform’s source code must follow the usual Java coding standard.

The Contributor must insert the suitable *javadoc* comments in every new file. The Contributor must insert the license description of the last distributed eXo Platform version in the starting section of every new source file. Every new source file must contain both the author’s name (who created the file), following the *javadoc* format, both his / her email address. When a Developer will submit the Contribution (a developer send a source code or documentation Contribution via email, but it is not a Contributor yet), the author’s name in the source file will be the Developer’s one. Also a “@contributor tag” will be inserted indicating the Contributor’s name. When this event occurs, the Contributor commit himself to send an email to the Developer notifying the Contribution. The Contributor must use the “note” field of the eXo Platform Project’s SCM repository inserting the suitable update description when he / her insert every new file. eXo can start a new digital signature procedure, by its exclusive right, by means of a digital certificate and password exchange, with the aim of a digital Contributor’s identification. In this event, the Contributor agree to use this procedure; it will be notified by eXo. The Contributor will be responsible of the Contributions of his / her competence following his / her digital certificate and password. He / her will be responsible for his / her authentication security; for this aim, the Contributor commit himself / herself to keep his / her digital certificate with a high level of security and not to disclose his / her password; he / her will be also responsible for every damage and harmful consequence caused to eXo or any third-party following this default.

Document Contribution

The Contributor must send documentation via email by means of the Project's Contributors List. Every document contains a history section. It contains the updated description and the author's name when he / her is not one of the document's owner, as written in the document's front-page *Contributor's acceptance and termination*.

A Developer who has sent in solid, useful source code and / or documentation Contributions and who asked to be a Contributor can be elevated to contributor status by eXo via an interactive, communicative process. He / her must sign this Agreement. eXo can exclude a Contributor from the Contributors' list, by its exclusive right, when this Contributor has not respected the above rules repeatedly or when he / her has not contributed for a long period (more than one year). If any of these events occur, any assignment under this Agreement for the Contributor's Contribution shall terminate, by a communication that eXo will send to the Contributor, starting from the date of this communication.

Contributor's responsibility

The Contributor owns and has the rights to contribute all source code and related material intended to be compiled or integrated with the source code for the eXo Platform software and documentation which Contributor has ever delivered, and Project has accepted, for incorporation into the technology made available under the eXo Platform Project. The Contributor grants to comply with the applicable laws and regulations, the eXo Platform licenses, terms of use, and the guiding principles concerning any use of copyrighted materials.

Copyright assignment by Contributor

Subject to the terms and conditions of this Agreement, the Contributor grants to eXo Platform SAS a perpetual, worldwide, no-charge, royalty-free, irrevocable, non-exclusive copyright license to use the Contribution and every derivative work according to the eXo Platform licenses. The Contributor represents that is legally entitled to grant the above assignment.

The Contributor represents that his/her Contribution is his / her original creation. The Contributor represents that his Contribution include complete details of any third-party license or other restriction of each he/she is personally aware and which are associated with any party of his/her Contribution.

The Contributor is legally entitled to grant the above assignments and agrees not to provide any Contribution that violates any law or breaches any contract.
